I VLADIMIR LASKEWICZ of 153 Acton Avenue, Rivervale in the State of Western Australia, Retired Welder, HEREBY REVOKE all former Wills and Testamentary Dispositions made by me AND I DECLARE this to be my last Will and Testament.

1. IF my wife ELENA LASKEWICZ shall survive me for a period of twenty eight days then subject to the payment of all my just debts funeral and testamentary expenses and all duties probate death estate succession or otherwise payable on or in respect of my estate or on or by reason of my death I GIVE DEVISE AND BEQUEATH to her for her sole use and benefit absolutely the whole of my estate of whatsoever kind and wheresoever situate and I APPOINT her the sole Executrix of this my Will PROVIDED THAT if my wife the said ELENA LASKEWICZ shall not survive me for the said period of twenty eight days then but not otherwise the following provisions of this my Will shall take effect.
2. I APPOINT my daughter LIDIA ROZLAPA ("my Trustee") the Executrix and Trustee of this my Will
3. I GIVE AND BEQUEATH free of all duties:
 - (a) The sum of ONE THOUSAND DOLLARS (\$1,000.00) to the Minister for the time being of THE RUSSIAN ORTHODOX CHURCH at 161 Whatley Crescent, Bayswater in the said State to be applied for the purposes of The Russian Orthodox Church in whatsoever manner the Minister for the time being of the said Church determines:
 - (b) The sum of TWO THOUSAND DOLLARS (\$2,000.00) to my nephew BENJAMIN LASKEWICZ:
 - (c) The sum of TWO THOUSAND DOLLARS (\$2,000.00) to my nephew ZACHAR LASKEWICZ.
4. I GIVE DEVISE AND BEQUEATH the rest and residue of my estate being of whatsoever kind or wheresoever situate to my Trustee UPON TRUST to sell call in and convert into money with power for my Trustee to postpone such

sale calling in and conversion for such period as my Trustee shall think fit and from the proceeds thereof and from my ready money to pay all my just debts funeral and testamentary expenses and all duties probate death estate succession or otherwise payable on or in respect of my estate or on or by reason of my death and to stand possessed of the residue then remaining (hereinafter referred to as "my residuary estate") UPON TRUST:

- (a) As to one third thereof for my daughter LIDIA ROZLAPA if she shall survive me PROVIDED THAT if she shall predecease me then for such of her children as shall survive me and if more than one as tenants in common in equal shares;
 - (b) As to one third thereof for my son LEONARD LASKEWICZ if he shall survive me PROVIDED THAT if he shall predecease me then for such of his children as shall survive me and if more than one as tenants in common in equal shares;
 - (c) As to one third thereof for such of my grandchildren MARK ANDREW ROZLAPA, KATHRYN LIDIA ROZLAPA and ANNA SARAH LIVINGSTONE who shall survive me and who have attained or shall live to attain the age of eighteen (18) years and if more than one as tenants in common in equal shares.
5. I EMPOWER my Trustee during the period prior to attaining the said age of eighteen (18) years by any child or remoter issue of mine who if of the age of eighteen (18) years would be entitled to a vested interest herein to apply the whole or any part or parts of the income and or capital of the share of such child or remoter issue whether vested or contingent for or towards his or her maintenance education advancement or benefit with liberty to pay the same to the guardian or guardians of such child or remoter issue for the purpose aforesaid without being liable to see to the application thereof AND my

Trustee shall accumulate the residue (if any) of the said income by investing the same and the resulting income thereof to the intent that such accumulations shall be added to the share from which the same shall have arisen and devolve therewith but with power for my Trustee at any time to apply such accumulations or any part thereof as if the same were income of the then current year.
